Student Acceptable Use Agreement for Technology Use

Students in Elk Island Public Schools (the Regional Division) are provided access to the Internet using the Division's Wide Area Network. The Internet, a network of computer networks, allows our students to interact with hundreds of thousands of networks and computers. Within our schools and libraries, the Internet and e-mail may be used by our students for educational purposes. There is no intent that students use Internet access from Division computers for personal use. The Internet is similar to other student learning resources such as books, magazines, videos, CD-ROMs and encyclopedias.

Conditions & Rules for Use

Elk Island Public Schools reserves the right to access, audit and monitor use of all supplied Information Technology (IT) resources for non-compliance to this policy, without prior notice to the user. There is no expectation of privacy on behalf of the user with regard to information technology resources.

It is a general policy that all computers used through the Division's networks are to be used in a responsible, efficient, ethical and legal manner. Failure to adhere to the policy and guidelines for the use of the network as described below will result in the revocation of access privileges and possible disciplinary action. Unacceptable uses of technologies include, but are not limited to:

- Using the network for any illegal activity, including violation of copyright or other laws.
- Using the network in ways which violate school policies and behavior standards.
- Using the network for financial or commercial gain.
- Degrading or disrupting equipment or system performance.
- Invading the privacy of other individuals by accessing and/or vandalizing their computerized data.
- Wasting technology resources, including bandwidth, file space, and printers by downloading music or video files, except for those identified as legitimate curriculum resources.
- Gaining unauthorized access to resources or entities.
- Using an account owned by other users with or without their permission.
- Posting personal communications, including photos of another person, without that other person's consent.
- Giving one's account and password information to other users.

Network Etiquette

All users are expected to abide by the generally accepted rules of network etiquette. These include, but are not limited to:

- Being polite in all communications to others.
- Using appropriate language.
- In all activities being compliant with municipal, provincial, federal or international law.
- Maintaining the confidentiality of personal addresses and phone numbers.
- Not using the network in such a way that it would disrupt the use of the network by others.
- Assuming that all communications and information accessible via the Internet are the private property of those who put it on the Internet.

Personal Devices (Wireless)

Students at this school may bring their own personal electronic devices which may be able to connect to the school wireless network. When at school, all of the conditions below apply to these student-owned, personal electronic devices:

- I will only connect to the school wireless network, and NOT to the school's wired network, or any other (external) wireless network, even though other networks for the neighborhood might be visible inside the school
- The device I am using will have up-to-date virus protection software.
- I will turn off all peer-to-peer (music/video/file-sharing) software or web-hosting services on my device while connected to the school wireless network and respect the personal information of others.
- I will use the student-owned device in class only with the teacher's express permission.

- I understand the security, care and maintenance of my device is my responsibility. I will securely store and charge my device when not in use.
- I understand the school is not responsible for the loss, theft, or damage of my device. I am fully responsible for my property while it is at school.
- I understand school and district technology staff members may access my personal electronic device if there are reasonable grounds to believe there has been a breach of school rules or discipline policies and that a search of the device would reveal evidence of the breach. This may include, but is not limited to, audio and video recording, photographs taken on school property that violate the privacy of others, and issues regarding bullying, etc.
- I will exercise appropriate security procedures at all times when using my own devices in conjunction with the school's wireless network. I will use technology in accordance with the Elk Island Public Schools' standards for the Acceptable Use of Technology, as well as the Board's Policies *IFC – Student Roles and Responsibilities* and *IG – Student Behavior Plan*

Vandalism and Harrassment

Vandalism is defined as any malicious attempt to harm, modify, or destroy data of another user, the Internet or other networks that are connected to the Internet. This includes, but is not limited to, the uploading or creating of computer viruses. Harrassment is defined as the persistent annoyance of another user or the interference of another user's work. Vandalism and harassment will result in cancellation of user privileges and possible disciplinary action.

Unacceptable Material

Because access to the Internet provides connections to other computer systems located all over the world, students (and parents) must understand that neither the Division nor any Division staff member controls the content of the information available on these other systems. Some sites accessible via the Internet may contain material that is inaccurate or inappropriate for educational use in a K-12 setting, such as hate literature, pornography, and information related to immoral or illegal activities. The Division does not condone the use of such materials and does not permit usage of such materials in the school environment. The Division uses Internet filtering software in addition to teacher supervision to reduce the likelihood of students accessing inappropriate Internet sites. In the event a student inadvertently accesses an inappropriate Internet site, he/she must advise the supervising teacher of the inadvertent access.

Penalties for Improper Use

Violation of the Division's Acceptable Use Policy may result in:

- restricted network access
- loss of network access
- disciplinary action
- legal action
