- Due to the budget, we will not be replacing the grade 2 teacher going on leave next year, and will combine both Grade 3 classes to form one slightly larger class. We will, however, look into extra EA's for class assistance.
- We are happy to announce that we will have three full time, permanent EA staff in the STEPS program, instead of multiple part-time rotating staff.

#### Westboro School Council - AGM

- Attended AI conference. Surprisingly enough, the classes related a lot to education and health care which both have pockets of innovation but are both very slow in developing.
   This is in comparison to a lot of private industries that have been incorporating AI for the last decade. Further examples of what was learned at the conference include:
  - Digital twinning, for example, can make digital versions and replicas of buildings and infrastructure to monitor everyone's coming and goings to help create the most streamlined systems they can. Personal digital twinning is where people can make a digital version of themselves based on their own likes/dislikes and searches.
  - AI will be coming into the schools in the coming years, and we need to teach both students and staff how to ethically use it. It will be helpful in deciding future curriculums, etc.
  - Anytime AI is used in the schools, for example if a teacher uses it to grade test papers, there MUST be a disclaimer somewhere on the paper informing both parents and students that it was AI and not the teacher that dealt with that particular paper.
  - We will need to make sure kids are using AI that is specifically designed for their age group, and we will need to learn to recognize indicators of what is false information.
  - One disclaimer to mention is that when it comes to AI, once you enter information into the system, not even the people who wrote the software knows WHERE the information goes or WHO it goes to. They aren't even sure HOW it makes the decisions it does.
- Last, but certainly not the least, this year has been Mr. Lastiwkas last year at Westboro. His new replacement, Shelby Labreque, will be joining us for the 24/25 school year.

# Trustee Report • Trina Boymook May 2024

 The Board has received an increase in our funding allocation to address student enrolment and covering the Teacher's collective agreement. There have been no increases to offset the cost of inflation and there has been no increase to the classroom complexity grant. In addition, no funding was received to extend support for the Reset Room Pilot Project.

In response to school assurance review and budget survey completed by parents and staff, classroom complexity has been identified as one of the key priority areas in building this budget. Without any increase in the classroom complexity grant, it has been decided to introduce a new way of allocating the specialized supports for inclusive students and system programs.

An algorithm has been established to includes factors the contribute to complexity in the classroom.

- Provincial Achievement and Diploma Test results including standard deviation/mean;
- socio-economic factors;
- o First Nation, Métis and Inuit self-identified students;
- English as an Additional Language;
- o students in care; and
- o students with non-levelled special education codes, and student population size.

\$1.508M has been allocated to schools based on the algorithm.

Classroom complexity grant of \$861,000, EIPS will use for the following items:

- o part of the classroom complexity allocation;
- o a Speech Language Pathologist Assistant position;
- o a Speech Language Pathologist Assistive Technology position; and
- o a Reading Specialist Consultant position. The use of reserves will be used to expand the READ program to all elementary schools for identified Grade 2 students.

The key priority areas in building the budget are

- Classroom Complexity
- Curriculum and resource development to support teachers
- Year 3 of the Mental Health Strategic Plan (through use of reserves)
- Continued pursuit of Collegiate School /Program and support for Career Pathways (through use of reserves)
- o Equity for rural schools, equity for all
- Retention of Staff
- Arifticial Intelligence (AI) considerations (through use of reserves)

The 2024-25 Budget will be a tight budget and it is anticipated that the 2025-26 Budget will even tighter.

### Trustee Report • Trina Boymook May 2024

• The Board approved the student transportation fees at the upcoming school year at its April 18 Board meeting, parents will see large decreases in fees for those eligible families (K- 6 residing over 1km Grades 7-12 Over 2km from registered school) who are attending school and program of choice. Dropping from \$175 to \$75. Ineligible riders fee will be \$150 for next year. Overall people will see sizeable decreases in fees for the upcoming year due to the new funding model introduced by the province last year. Deadline for paying fees is June 30, 2024. Those that don't pay by the deadline will need to pay a \$25 late fee.

Funding should be prioritized based on an assessment of need and factors such as existing playgrounds age/condition, social vulnerability, access to other funding sources, school population, and location of adjacent public playgrounds accessible to the school" as a second paragraph.

- 2) To collaborate closely with the Alberta Government, school districts, and other relevant stakeholders to gather data, assess needs, and prioritize infrastructure projects based on educational necessity rather than political influence.
- 3) To implement a comprehensive public engagement strategy that includes regular updates via social media, press releases, and public forums, allowing for parent and community input into the planning and prioritization processes.
- 4) To ensure that the task force's findings and recommendations are presented in a timely manner with a detailed progress report that is shared publicly.
- 5) To establish mechanisms for ongoing review and adaptation of the infrastructure strategy to respond to new challenges and opportunities as they arise.
- 6) To advocate for amendments to the Alberta Education Act to make the prioritization of school builds transparent, providing clear criteria and timelines accessible to all parents and communities, ensuring that decisions on when and where schools are built are made public, regardless of the school board.
- 7) To ensure that no school exceeds 100% capacity a situation where students do not have access to a school in their area.
